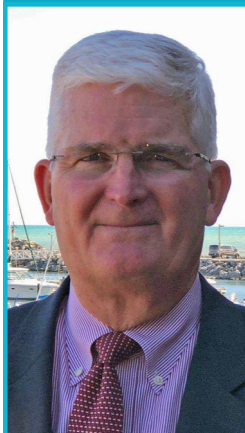


The Board is comprised of seven (7) members, four of which are appointed by the Mayor of Waukegan and three of which are appointed by the Governor of Illinois (each via its own internal policies & procedures). Board Members serve an initial 6-year term, unless appointed to fill a vacancy.



Grant Farrell  
Chairman

Grant, a Waukegan native, fondly recalls exploring the Waukegan Harbor and lakefront during his youth. A graduate of Waukegan High School, he later attended Roosevelt University in Chicago where he received a certificate of Labor Leadership. Grant is a lifelong resident of Lake County and currently lives in Lake Forest. As a licensed pilot since 1975, he has flown fifteen different types of aircraft from jets to helicopters and hangars his YAK 52 Warbird at the Waukegan Airport.
